Make provision for the establishment of the Local Better Regulation Office; for the co-ordination of regulatory enforcement by local authorities; for the creation of civil sanctions in relation to regulatory offences; for the reduction and removal of regulatory burdens; and for connected purposes.

B E IT ENACTED by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows: –

PART 1

THE LOCAL BETTER REGULATION OFFICE

Establishment of LBRO

1 LBRO

- (1) The Local Better Regulation Office is established as a body corporate.
- (2) In Parts 1 and 2 it is referred to as "LBRO".
- (3) Schedule 1 (which makes further provision about LBRO) has effect.

2 Dissolution of the LBRO company

- (1) The company limited by guarantee with registered number 6237580 and the company name Local Better Regulation Office (in this Part called "the LBRO company") is dissolved.
- (2) The registrar of companies for England and Wales must strike the name of the LBRO company off the register of companies before the end of the period of seven days beginning with the day on which this section comes into force.

(3) Schedule 2 (which makes provision relating to the replacement of the LBRO company by LBRO) has effect.

Definitions

3 "Local authority"

- (1) In this Part references to a local authority in England are to any of the 5 following—
 - (a) a county or district council in England;
 - (b) a London borough council;
 - (c) the Common Council of the City of London;
 - (d) the Sub-Treasurer of the Inner Temple and the Under-Treasurer of the 10 Middle Temple;
 - (e) the Council of the Isles of Scilly;
 - (f) a fire and rescue authority in England (not being an authority referred to in paragraphs (a) to (e);
 - (g) a port health authority in England (not being an authority referred to in 15 paragraphs (a) to (e));
 - (h) an authority established under section 10 of the Local Government Act 1985 (c. 51) (waste disposal authorities for Greater London and metropolitan counties).

(2) In this Part references to a local authority in Wales are to any of the following - 20

- (a) a county or county borough council in Wales;
- (b) a fire and rescue authority in Wales (not being a county or county borough council);
- (c) a port health authority in Wales (not being a county or county borough council).

4 "Relevant function"

- (1) In this Part "relevant function", in relation to a local authority in England or Wales, means
 - (a) a function under a relevant enactment of imposing requirements, restrictions or conditions, or setting standards or giving guidance, in 30 relation to any activity, or
 - (b) a function which relates to the securing of compliance with, or the enforcement of, requirements, restrictions, conditions, standards or guidance which under or by virtue of a relevant enactment relate to any activity.
- (2) In subsection (1) "relevant enactment" means
 - (a) an enactment specified in Schedule 3 or an enactment made under such an enactment;
 - (b) an enactment to which subsection (3) applies.
- (3) This subsection applies to any enactment made under section 2(2) of the European Communities Act 1972 (c. 68) with respect to any of the following matters
 - (a) agricultural produce (quality standards and labelling);
 - (b) animal health and welfare;

- (c) animal feed;
- (d) consumer protection;
- (e) environmental protection;
- (f) food hygiene and standards;
- (g) public health and safety;
- (h) weights and measures (including measuring instruments).
- (4) The Secretary of State may by order
 - (a) amend Schedule 3 so as to add any enactment to it or to remove any enactment from it;
 - (b) amend subsection (3) so as to add any matter to it or remove any matter 10 from it.
- (5) An order under subsection (4) may make different provision for different purposes (including different provision in relation to local authorities in England and Wales respectively).
- (6) An order under subsection (4) requires the consent of the Welsh Ministers to make provision, in relation to local authorities in Wales, in respect of a Welsh ministerial matter.
- (7) The Secretary of State may by order determine whether, for the purposes of subsection (3), an enactment made under section 2(2) of the European Communities Act 1972 (c. 68) is made with respect to any of the matters 20 specified in that subsection.
- (8) An order under subsection (7) requires the consent of the Welsh Ministers where
 - (a) the determination affects the application of this Part in relation to local authorities in Wales, and
 - (b) the enactment made under section 2(2) of the European Communities Act 1972 relates to a Welsh ministerial matter.
- (9) In subsection (1)
 - (a) references to a function do not include a function of conducting criminal or civil proceedings;
 - (b) references to an activity include providing goods and services and employing or offering employment to any person.

General functions of LBRO

5 **Objective relating to general functions**

- In exercising its functions under sections 6 to 10 LBRO has the objective of securing that local authorities in England and Wales exercise their relevant functions –
 - (a) effectively,
 - (b) in a way which does not give rise to unnecessary burdens, and
 - (c) in a way which conforms with the principles in subsection (2).
- (2) Those principles are that
 - (a) regulatory activities should be carried out in a way which is transparent, accountable, proportionate and consistent;

(b) regulatory activities should be targeted only at cases in which action is needed.

6 Guidance to local authorities

- (1) LBRO has the function of giving guidance to local authorities in England and Wales as to how to exercise their relevant functions.
- (2) Guidance under subsection (1)
 - (a) may be given to any one or more local authorities in England or Wales;
 - (b) may relate to any one or more relevant functions;
 - (c) may relate to the exercise of one or more relevant functions in a particular case.
- (3) A local authority in England or Wales must have regard to any guidance given to it under this section.
- (4) Before giving guidance under this section in relation to any relevant function LBRO must consult
 - (a) the persons whose activities are regulated by the exercise of the 15 function, or persons representative of such persons,
 - (b) such local authorities in England and Wales, or such persons representative of local authorities in England and Wales, as LBRO considers appropriate, and
 - (c) such other persons as LBRO considers appropriate.
- (5) LBRO must publish (in such manner as it considers appropriate) any guidance given by it under this section.
- (6) LBRO may vary or revoke any guidance given by it under this section by further guidance under this section.

7 Guidance to local authorities: enforcement

- (1) LBRO may at any time, if it thinks it appropriate to do so, direct one or more local authorities in England or Wales to comply with
 - (a) any guidance given under section 6 which relates to the exercise of a relevant function, or
 - (b) any guidance given under an enactment by another person which 30 relates to the exercise of a relevant function.
- (2) LBRO may not give a direction under this section without the consent of the Secretary of State, except in a case to which subsection (3) applies.
- (3) LBRO may not give a direction under this section to one or more local authorities in Wales in relation to a Welsh ministerial matter without the consent of the Welsh Ministers.
- (4) Where a direction under this section relates to two or more local authorities in England and Wales, consent under subsection (2) or (3) must be given by order.
- (5) Before giving a direction under this section LBRO must consult
 - (a) any relevant regulator, and
 - (b) such other persons as LBRO considers appropriate.

- In subsection (5)(a) "relevant regulator" means a person (other than a local (6) authority in England or Wales) with regulatory functions which relate to the matter to which the direction relates.
- (7) LBRO must publish (in such manner as it considers appropriate) any direction given by it under this section.
- (8)A direction under this section may be revoked or varied by a further direction under this section.

8 Financial support and assistance to local authorities

LBRO may provide financial support and assistance –

- to a local authority in England or Wales in relation to its exercise of its 10 (a) relevant functions;
- to any other person for the purpose of assisting local authorities in (b) England or Wales in the exercise of their relevant functions.

9 Advice to Ministers of the Crown

- (1) LBRO may at any time give advice or make proposals to a Minister of the 15 Crown on –
 - the way in which any one or more local authorities in England or Wales (a) exercise any of their relevant functions;
 - the effectiveness of legislation relating to the exercise by local (b) authorities in England or Wales of their relevant functions;
 - whether any other regulatory functions could appropriately be (c) exercised by local authorities in England or Wales;
 - any other matter relating to the exercise by local authorities in England (d) or Wales of their relevant functions.
- 25 (2) LBRO must give advice or make proposals to a Minister of the Crown on the matters referred to in subsection (1) if requested to do so by that Minister.

10 Advice to Welsh Ministers

- LBRO may at any time give advice or make proposals to the Welsh Ministers (1)on-
 - 30 the way in which any one or more local authorities in Wales exercise (a) any of their relevant functions in relation to any Welsh ministerial matter;
 - the effectiveness of legislation relating to the exercise by local (b) authorities in Wales of their relevant functions in relation to any such matter:
 - whether any other regulatory functions could appropriately be (c) exercised by local authorities in Wales in relation to any such matter;
 - anything else relating to the exercise by local authorities in Wales of (d) their relevant functions in relation to any such matter.
- LBRO must give advice or make proposals to the Welsh Ministers on the 40 (2) matters referred to in subsection (1) if requested to do so by the Welsh Ministers.

Function relating to enforcement priorities

11 Enforcement priorities

- (1) LBRO must prepare and publish
 - (a) a list specifying those matters to which a local authority in England should give priority when allocating resources to its relevant functions, and
 - (b) a list specifying those matters to which a local authority in Wales should give priority when allocating resources to its relevant functions.
- (2) A local authority in England or Wales must have regard to the appropriate list under subsection (1) when allocating resources to its relevant functions.
- (3) Before publishing a list under subsection (1) LBRO must consult such persons as it considers appropriate.
- (4) LBRO must publish details of any representations made to it pursuant to subsection (3).
- (5) LBRO may not publish a list under subsection (1)(a) without the consent of the 15 Secretary of State.
- (6) LBRO may not publish a list under subsection (1)(b)
 - (a) without consulting the Secretary of State;
 - (b) without the consent of the Welsh Ministers.
- (7) LBRO must review a list under this section
 - (a) from time to time on its own initiative;
 - (b) if requested to do so by the Secretary of State;
 - (c) in the case of a list under subsection (1)(b), if requested to do so by the Welsh Ministers.
- (8) If following a review LBRO decides to revise a list under this section it must publish the revised list (and subsections (2) to (7) have effect in relation to any revised list).

Matters relating to exercise of LBRO's functions

12 Relationship with other regulators

- LBRO and a regulator to which this section applies must enter into a memorandum of understanding with each other as to how they will work together in the exercise of their respective functions.
- (2) This section applies to the following regulators
 - (a) the Environment Agency;
 - (b) the Food Standards Agency;
 - (c) the Gambling Commission;
 - (d) the Health and Safety Executive;
 - (e) the Office of Fair Trading.

13 Duty not to impose burdens etc

(1) LBRO must secure that in exercising any of its functions it does not – 40

(7) The Secretary of State may by order require LBRO to exercise its functions under section 7 in relation to two or more local authorities in England and Wales in such manner as may be specified in the order.

16 Guidance or directions by Welsh Ministers

- (1) The Welsh Ministers may give LBRO-
 - (a) guidance, or
 - (b) directions,

as to the exercise in relation to Wales of any of its functions relating to a Welsh ministerial matter.

- (2) Before giving any guidance or directions under this section the Welsh 10 Ministers must consult –
 - (a) LBRO, and
 - (b) such other persons as the Welsh Ministers consider likely to be affected by the guidance or directions, or persons representative of such persons.
- (3) The Welsh Ministers must
 - (a) publish (in such manner as they consider appropriate) any guidance or directions given under this section, and
 - (b) lay a copy of any such guidance or directions before the National Assembly for Wales.
- (4) LBRO must have regard to any guidance, and comply with any directions, given under this section.
- (5) The Welsh Ministers may vary or revoke any guidance or directions given under this section by further guidance or directions under this section.
- (6) The Welsh Ministers may not under subsection (1)(b) give LBRO directions 25 relating to the exercise of its functions under section 7 in relation to two or more local authorities in Wales.
- (7) The Welsh Ministers may by order require LBRO to exercise its functions under section 7 in relation to two or more local authorities in Wales, so far as relating to a Welsh ministerial matter, in such manner as may be specified in 30 the order.

Supplementary and general

17 Power to dissolve LBRO

- (1) The Secretary of State may by order
 - (a) provide for LBRO to be dissolved, and
 - (b) make consequential, supplementary, incidental and transitional provision in relation to its dissolution.
- (2) An order under subsection (1) may in particular
 - (a) provide for the transfer of the property, rights and liabilities of LBRO to another person;
 - (b) provide for the transfer of the functions of LBRO to another person;

- (c) provide that anything done by or in relation to LBRO is, so far as is necessary for continuing its effect, to have effect as if done by or in relation to another person;
- (d) provide for anything (which may include legal proceedings) which is in the process of being done by or in relation to LBRO when a transfer under the order takes effect to be continued by or in relation to another person;
- (e) provide for a reference to LBRO in an enactment, instrument or other document to be treated as a reference to another person.
- (3) Provision under subsection (2)(a) may include provision for property, rights or 10 liabilities to be transferred
 - (a) whether or not they would otherwise be capable of being transferred,
 - (b) without any instrument or other formality being required, and
 - (c) despite any provision (of whatever nature) which would otherwise prevent, penalise or restrict their transfer.
- (4) Provision under subsection (2)(a) for the transfer of rights and liabilities relating to employees of LBRO must include provision for the Transfer of Undertakings (Protection of Employment) Regulations 2006 (SI 2006/246) to apply in relation to the transfer.
- (5) Provision under subsection (2)(a) or (b) may include provision establishing a 20 body corporate to which property, rights and liabilities, or functions, are transferred.

(6) Before making an order under this section the Secretary of State must consult –

- (a) the Welsh Ministers, and
- (b) such persons (or persons representative of such persons) as appear to the Secretary of State to be substantially affected by the dissolution of LBRO.
- (7) The provision which may be made by an order under this section may be made by repealing, revoking or amending an enactment (whenever passed or made).

18 Dissolution of LBRO: tax

- (1) Where an order under section 17 makes provision under subsection (2)(a) of that section, the Treasury may by regulations make provision for varying the way in which a relevant tax has effect in relation to
 - (a) the property, rights or liabilities transferred, or
 - (b) anything done for the purposes of, or in relation to, the transfer.
- (2) The provision which may be made under subsection (1)(a) includes in particular provision for
 - (a) a tax provision not to apply, or to apply with modifications, in relation to the property, rights or liabilities transferred;
 - (b) the property, rights or liabilities transferred to be treated in a specified 40 way for the purposes of a tax provision;
 - (c) the Secretary of State to be required or permitted, with the consent of the Treasury, to determine, or specify the method for determining, anything which needs to be determined for the purposes of any tax provision so far as relating to the property, rights or liabilities transferred.

- (3) The provision which may be made under subsection (1)(b) includes in particular provision for
 - (a) a tax provision not to apply, or to apply with modifications, in relation to anything done for the purposes of, or in relation to, the transfer;
 - (b) anything done for the purposes of, or in relation to, the transfer to have or not have a specified consequence or be treated in a specified way;
 - (c) the Secretary of State to be required or permitted, with the consent of the Treasury, to determine, or specify the method for determining, anything which needs to be determined for the purposes of any tax provision so far as relating to anything done for the purposes of, or in relation to, the transfer.
- (4) In this section –

"relevant tax" means income tax, corporation tax, capital gains tax, stamp duty or stamp duty reserve tax;

"tax provision" means a provision of an enactment about a relevant tax.

19 Orders under Part 1

- (1) An order or regulations under this Part must be made by statutory instrument.
- (2) A statutory instrument containing an order made by the Secretary of State under section 4(7), 7(4) or 15(7) is subject to annulment in pursuance of a resolution of either House of Parliament.
- (3) A statutory instrument containing an order made by the Secretary of State under section 4(4) or 17 may not be made unless a draft of the instrument has been laid before, and approved by resolution of, each House of Parliament.
- (4) A statutory instrument containing an order made by the Welsh Ministers under section 7(4) or 16(7) is subject to annulment in pursuance of a resolution of the National Assembly for Wales.
- (5) A statutory instrument containing regulations made by the Treasury under section 18 is subject to annulment in pursuance of a resolution of the House of Commons.

20 Interpretation of Part 1

In this Part –

"LBRO" has the meaning given in section 1; "the LBRO company" has the meaning given in section 2; "local authority" has the meaning given in section 3; "relevant function" has the meaning given in section 4.

PART 2

CO-ORDINATION OF REGULATORY ENFORCEMENT

Introductory

21 Scope of Part 2

(1) This Part applies where –

- (a) a person carries on an activity in the area of two or more local authorities, and
- (b) each of those authorities has the same relevant function in relation to that activity.
- (2) In this Part "the regulated person" means the person referred to in subsection 5 (1)(a).

22 "Local authority"

- (1) In this Part "local authority" means a local authority in England, Wales, Scotland or Northern Ireland.
- (2) In this Part references to a local authority in England or Wales have the same 10 meaning as in Part 1.
- (3) In this Part references to a local authority in Scotland are to a council constituted under section 2 of the Local Government etc. (Scotland) Act 1994 (c. 39).
- (4) In this Part references to a local authority in Northern Ireland are to a district 15 council constituted under section 1 of the Local Government Act (Northern Ireland) 1972 (c. 9).

23 "Relevant function"

- (1) In this Part "relevant function"
 - (a) in relation to a local authority in England or Wales, has the same 20 meaning as in Part 1;
 - (b) in relation to a local authority in Scotland, means a regulatory function exercised by that authority and specified for the purposes of this Part by order made by the Secretary of State;
 - (c) in relation to a local authority in Northern Ireland, means a regulatory
 25 function exercised by that authority and specified for the purposes of this Part by order made by the Secretary of State.
- (2) An order under subsection (1)(b) or (c) may only specify a regulatory function
 - (a) which is a relevant function for the purposes of Part 1 in relation to local 30 authorities in England or Wales or both, or
 - (b) which for the purposes of local authorities in Scotland or Northern Ireland is equivalent to such a function.
- (3) An order under subsection (1)(b) may not specify a regulatory function so far as exercisable in Scotland, if or to the extent that the function relates to matters
 35 which are not reserved matters.
- (4) An order under subsection (1)(c) may not specify a regulatory function so far as exercisable in Northern Ireland, if or to the extent that the function relates to matters which are transferred matters.
- (5) In subsection (3) "reserved matter" and "Scotland" have the same meanings as 40 in the Scotland Act 1998 (c. 46).
- (6) In subsection (4) "transferred matter" and "Northern Ireland" have the same meanings as in the Northern Ireland Act 1998 (c. 47).

5

Primary authorities

24 Primary authorities

- (1) For the purposes of this Part LBRO may nominate a local authority to be the "primary authority" for the exercise of the relevant function in relation to the regulated person.
- (2) Sections 26 to 31 apply in any case where a primary authority is nominated under this section in relation to the regulated person.

25 Nomination of primary authorities

(1)	LBRO may only nominate a local authority under section 24(1) in relation to the regulated person if –	10
	(a) the authority and the regulated person have agreed in writing to the nomination, or

- (7) Schedule 4 (which makes provision for questions arising under this section to be referred to LBRO) has effect.

- (f) as to monitoring by a regulator of compliance with an undertaking;
- (g) as to certification by a regulator that an undertaking has been complied with;
- (h) for appeals against refusal to give such certification;
- (i) in a case where a person has given inaccurate, misleading or incomplete information in relation to the undertaking, for that person to be regarded as not having complied with it;
- (j) in a case where a person has complied partly but not fully with an undertaking, for that part-compliance to be taken into account in the 15 imposition of any criminal or other sanction on the person;
- (k) for the purpose of enabling criminal proceedings to be instituted against a person in respect of the relevant offence in the event of breach of an undertaking or any part of it, to extend any period within which those proceedings may be instituted.

- (1) An order under this Part may not provide for the making of an appeal other than to -
 - (a) the First-tier Tribunal, or
 - (b) another tribunal created under an enactment.

Orders under Part 3: exclusions

 - (5) LBRO is to pay to or in respect of the ordinary members such sums as the Secretary of State may determine by way of or in respect of remuneration, allowances, expenses, pensions or gratuities.
 - (6) If the Secretary of State thinks that there are special circumstances that make
 20 it right for a person ceasing to be an ordinary member of LBRO to receive compensation, LBRO must pay to that person such compensation as the Secretary of State may determine.
- 4 (1) The ex officio members are to be
 - (a) the Chief Executive of LBRO (see paragraph 7), and
 - (b) such other employees of LBRO as may for the time being be appointed by the chair after consulting the Chief Executive.
 - (2) The number of ex officio members appointed under sub-paragraph (1)(b) may not at any time exceed
 - (a) such number as may for the time being be specified by the Secretary 30 of State, or
 - (b) half the number of ordinary members.
 - Service as a member of LBRO is not service in the civil service of the State.

25

Tenure

- 6 (1) Subject to the other provisions of this Schedule, a person holds and vacates office as a member of LBRO in accordance with the terms and conditions of his or her appointment.
 - (2) A person may not be appointed as an ordinary member of LBRO for a term of more than five years.
 - (3) A person may at any time resign as an ordinary member of LBRO by giving notice in writing to the Secretary of State.
 - (4) The Secretary of State may remove a person as an ordinary member of LBRO at any time if
 - (a) the ordinary member has, at any time, been convicted of a criminal offence, or
 - (b) in the opinion of the Secretary of State
 - (i) the ordinary member has failed to comply with the terms of his or her appointment, or
 - (ii) the ordinary member is otherwise unable, unfit or unwilling to perform his or her functions.
 - (5) A person who has ceased to be an ordinary member is eligible for reappointment for a further term or terms but the total period of appointment of an ordinary member (whether or not in consecutive terms) 20 may not exceed ten years.

Employees

- 7 (1) LBRO is to have a Chief Executive.
 - (2) The Chief Executive is to be an employee of LBRO.
 - (3) The first Chief Executive is to be appointed by the Secretary of State.
 - (4) A Chief Executive after the first is to be appointed by LBRO with the approval of the Secretary of State.
 - (5) LBRO may appoint other employees, subject to the approval of the Secretary of State as to numbers and terms and conditions of employment.
 - (6) Service as an employee of LBRO is not service in the civil service of the State. 30
 - (7) LBRO may pay to or in respect of an employee sums by way of or in respect of remuneration, allowances, expenses, pensions, gratuities or compensation for loss of employment, subject to any conditions imposed by the Secretary of State under sub-paragraph (5).
 - (8) The Chief Executive may not take part in the determination of the amount of any remuneration, allowance, pension, gratuity or compensation payable to him or her.

Committees

- 8 (1) LBRO may establish one or more committees.
 - (2) A committee established under this paragraph may include persons who are 40 neither members nor employees of LBRO.

- (3) A committee established under this paragraph may establish one or more sub-committees.
- (4) LBRO may pay sums by way of or in respect of expenses to or in respect of a person who is a member of a committee or a sub-committee established under this paragraph but who is not a member or employee of LBRO.

Proceedings

- 9 (1) Subject to this Schedule, LBRO may regulate
 - (a) its own proceedings (including quorum), and
 - (b) the proceedings (including quorum) of any of its committees.
 - (2) A committee of LBRO may regulate the proceedings (including quorum) of 10 any of its sub-committees.
 - (3) The validity of proceedings of LBRO, or of any of its committees or subcommittees, is not affected by –
 - (a) a vacancy, or
 - (b) a defective appointment.

Delegation

10 LBRO may delegate any of its functions to any of its members, employees, committees or sub-committees.

Funding

- 11 (1) The Secretary of State may make grants to LBRO of such amounts as the 20 Secretary of State thinks fit.
 - (2) A grant under sub-paragraph (1) may be subject to such conditions as the Secretary of State thinks fit.
 - (3) The Welsh Ministers may make grants to LBRO of such amounts as they think fit.
 - (4) A grant under sub-paragraph (3) may be subject to such conditions as the Welsh Ministers think fit.

Annual report

- 12 (1) LBRO must, as soon as practicable after the end of each financial year, produce a report on the discharge of its functions during that year.
 - (2) LBRO must send a copy of the report to
 - (a) the Secretary of State, and
 - (b) the Welsh Ministers.
 - (3) The report must be sent under sub-paragraph (2)(a) within such period beginning with the end of the financial year to which the report relates as the Secretary of State may direct.
 - (4) The report must be sent under sub-paragraph (2)(b) within such period beginning with the end of the financial year to which the report relates as the Welsh Ministers may direct.

- 13 (1) LBRO must keep proper accounts and proper records in relation to the accounts.
 - (2) LBRO must prepare a statement of accounts for each financial year.

(3)	The statement of accounts must comply with any directions given by the	
	Secretary of State with the consent of the Treasury as to –	

- (a) the information to be contained in the statement;
- (b) the form which the statement is to take;
- (c) the manner in which the information is to be presented;
- (d) the methods and principles according to which the statement is to be prepared.
- (4) LBRO must send copies of the statement of accounts to the Secretary of State and the Comptroller and Auditor General within such period as the Secretary of State directs.

 - (a) starting on the day on which section 1 comes into force, and
 - (b) ending on the following 31 March.

Instruments and authentication

- 15 (1) The fixing of the seal of LBRO shall be authenticated by the signature of the 35 chair or of another person authorised by LBRO to act for that purpose.
 - (2) A document purporting to be duly executed under the seal of LBRO, or to be signed on LBRO's behalf, shall be received in evidence and, unless the contrary is proved, shall be treated as having been so executed or signed.

SCHEDULE 2

REPLACEMENT OF THE LBRO COMPANY BY LBRO

Transfer of staff

- 1 (1) For the purposes of TUPE –
 - the functions conferred on LBRO by this Act are to be treated as (a) transferred to LBRO from the LBRO company on the day on which section 2 comes into force;
 - (b) that transfer of functions is to be treated as a transfer of an undertaking to which TUPE applies;
 - each person who was, immediately before the day on which section 10 (c) 2 comes into force, employed by the LBRO company under a contract of employment is to be treated as employed in the undertaking immediately before that day.
 - (2) In sub-paragraph (1) "TUPE" means the Transfer of Undertakings (Protection of Employment) Regulations 2006 (SI 2006/246).

Transfer of property, rights and liabilities

- (1) All the property, rights and liabilities to which the LBRO company was 2 entitled or subject immediately before the day on which section 2 comes into force become on that day property, rights and liabilities of LBRO.
 - (2) In sub-paragraph (1) the reference to rights and liabilities does not include 20 rights and liabilities under or in connection with a contract of employment which are transferred pursuant to paragraph 1.

(3) Sub-paragraph (1) operates in relation to property, rights and liabilities –

- whether or not they would otherwise be capable of being (a) transferred;
- (b) without any instrument or other formality being required;
- despite any provision (of whatever nature) which would otherwise (c) prevent, penalise or restrict their transfer.

Tax

- 3 (1) For the purposes of any enactment about income tax or corporation tax, 30 LBRO and the LBRO company are to be treated as the same person.
 - (2) In particular, the transfers effected by paragraphs 1 and 2 are to be disregarded for those purposes.
 - (3) Accordingly, those transfers are not to be regarded for the purposes of Schedule 29 to the Finance Act 2002 (c. 23) (gains and losses from intangible fixed assets) as involving any realisation of an asset by the LBRO company or acquisition of an asset by LBRO.
 - (4) No transfer effected by paragraph 2 is to give rise to any liability to stamp duty land tax.

Continuity between the LBRO company and LBRO

- 4 (1) Anything done by or in relation to the LBRO company which has effect immediately before the day on which section 2 comes into force is, so far as is necessary for continuing its effect on or after that day, to have effect as if done by or in relation to LBRO.
 - (2) If before the day on which section 2 comes into force any consultation was undertaken by the LBRO company which, had it been undertaken by LBRO on or after that day, would to any extent have satisfied any consultation requirement to which LBRO is subject, that requirement may to that extent be taken to have been satisfied.
- 5 Anything (including legal proceedings) which, immediately before the day on which section 2 comes into force, is in the process of being done by or in relation to the LBRO company may be continued by or in relation to LBRO.
- 6 So far as is necessary or appropriate in consequence of paragraph 2, on and after the day on which section 2 comes into force, a reference to the LBRO company in an enactment, instrument or other document is to be treated as a reference to LBRO.

ENFORCEMENT ACTION: REFERENCES TO LBRO

Reference by enforcing authority

- 1 (1) If the primary authority directs the enforcing authority as specified in section 27(2), the enforcing authority may with the consent of LBRO refer the proposed enforcement action to LBRO.
 - (2) On a reference under this paragraph
 - (a) if LBRO is satisfied as to the matters in sub-paragraph (3), it must confirm the direction;
 - (b) in any other case, it must revoke the direction (and section 27(4)(b) shall accordingly cease to apply in relation to the direction).

- (a) the proposed enforcement action is inconsistent with advice or guidance previously given by the primary authority (generally or specifically),
- (b) the advice or guidance was correct, and
- (c) the advice or guidance was properly given by the primary authority.
- (4) Where under sub-paragraph (2) LBRO confirms a direction of the primary authority, it may direct the enforcing authority to take some other enforcement action (and section 27(1) to (4) does not apply in relation to that action).
- (5) The enforcing authority must comply with any direction under subparagraph (4).

Reference by regulated person

- 2 (1) If the primary authority does not direct the enforcing authority as specified in section 27(2), the regulated person may with the consent of LBRO refer the action to LBRO.

 - (b) in any other case, it must consent to the action.
 - (3) The matters referred to in sub-paragraph (2) are that
 - (a) the proposed enforcement action is inconsistent with advice or guidance previously given by the primary authority (generally or specifically),
 - (b) the advice or guidance was correct, and
 - (c) the advice or guidance was properly given by the primary authority. 40

 - (b) at any time after the making of a reference under this section and 10 before its determination.

Consultation

- 5 (1) Before making a determination for the purposes of this Schedule LBRO
 - (a) must consult any relevant regulator, where appropriate, and
 - (b) may consult such other persons as it thinks fit.
 - (2) In sub-paragraph (1)(a) "relevant regulator" means a person (other than a local authority) with regulatory functions which relate to the matter to which the determination relates.

Procedure: general

- 6 (1) LBRO must determine any reference under this Schedule within the period 20 of 28 days beginning with the day on which the reference is made.
 - (2) The Secretary of State may by order make further provision as to the procedure to be followed, for the purposes of this Schedule, by the primary authority, the enforcing authority, the regulated person and LBRO.

Guidance and directions

- 7 (1) LBRO may give guidance or directions to any one or more local authorities about any enforcement action referred to it.
 - (2) A local authority must have regard to any guidance, and comply with any direction, given to it under sub-paragraph (1).
 - (3) LBRO must publish any guidance or directions given under this paragraph 30 in such manner as it considers appropriate.

Information

8 For the purposes of this Schedule LBRO may require the primary authority, the enforcing authority or the regulated person to provide it with such information as it may specify, being information which the authority may lawfully provide to LBRO.
