TO

Establish a Marine Navigation Aids Commission; to establish an Office of Marine Navigation Aids Regulation; to amend the Merchant Shipping Act 1995; and for connected purposes.

B E IT ENACTED by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows: —

1 Establishment of Marine Navigation Aids Commission

- (1) There shall be a body corporate known as the Marine Navigation Aids Commission ("the Commission"), funded by the General Lighthouse Fund.
- (2) The Commission shall not be regarded as the servant or agent of the Crown or as enjoying any status, immunity or privilege of the Crown; and its property shall not be regarded as property of, or held on behalf of, the Crown.
- (3) The purposes of the Commission shall be to—
 - (a) operate and maintain navigation aids in a safe and cost effective manner, and
 - (b) collect light dues, as defined in section 205(1) of the Merchant Shipping Act 1995 (c. 21), payable by ships entering English, Welsh, Scottish and Northern Irish waters.
- (4) At the commencement of this Act, the responsibilities of the general lighthouse authorities, as defined in section 193 (general and local lighthouse authorities) of the Merchant Shipping Act 1995, regarding the operation and maintenance of marine navigation aids, shall be transferred to the Marine Navigation Aids Commission.

2 Membership of Marine Navigation Aids Commission

- (1) The Secretary of State shall appoint
 - (a) a chairperson of the Commission,
 - (b) in consultation with the chairperson, between nine and eleven other members of the Commission, at least four of whom should represent

5		Membe	ership of Office of Marine Navigation Aids Regulation
	(1)	The Se	cretary of State shall appoint –
		(a)	a chairperson of the Office,
		(b)	in consultation with the chairperson, at least four other members.

(2) The chairperson or another member —
 (a) may not be appointed for a term of more than five years (but may be reappointed),

(b) may resign by notice in writing to the Secretary of State, and

(c) shall hold and vacate office in accordance with the terms of his appointment.

(3) Before appointing a person as a member of the Office the Secretary of State must be satisfied that the person neither has nor is expected to acquire a financial or other personal interest which is likely to influence the performance of his functions as a member.

(4) The Secretary of State may dismiss a member of the Office by notice in writing on the grounds that the member —

(a) has been absent from meetings of the Office without permission of the Office during a period of more than three months,

(b) has a financial or other personal interest which is likely to influence the performance of his functions as a member,

(c) is the subject of a bankruptcy restrictions order (or interim order),

(d) has had his estate sequestrated in Scotland or, under Scots law, has made a composition or arrangement with, or granted a trust deed for, his creditors,

(e) has misbehaved, or

(f) is unable, unfit or unwilling to perform his functions as a member.

(5) The Office shall appoint a Chief Executive, after –

(a) consulting the Secretary of State, and

(b) obtaining the Treasury's approval of the terms and conditions of appointment.

6 Interpretation

In this Act "navigation aids" includes lighthouses, buoys, beacons and any other aids which enable the safe navigation of marine vessels.

7 Areas

Section 193 of the Merchant Shipping Act 1995 (c. 21) is amended as follows –

- (a) omit subsections (1) and (3),
- (b) for subsection (4)(a) substitute
 - "(a) in relation to the Marine Navigation Aids Commission, England, Wales, Scotland, Northern Ireland and the adjacent seas and islands;"

(c) for subsection (5) substitute –

"(5) The Marine Navigation Aids Commission is responsible for lighthouses in Gibraltar, the Channel Islands and the Isle of Man, and their surrounding seas.

(6) In subsection (4)(a) references to the seas include seas in an area specified by virtue of section 129(2)(b)."

8 Commercial activities

- (1) The Merchant Shipping Act 1995 (c. 21) is amended as follows.

- (1) The Marine Navigation Aids Commission may enter into agreements
 - (a) for the use by others of assets of the Commission ("hire agreements");

- (b) for the provision of consultancy or other services by the Commission ("service agreements").
- (2) The Marine Navigation Aids Commission may not enter into a hire or service agreement unless—
 - (a) it is satisfied that it is not likely to prejudice the discharge of its functions under section 195, and
 - (b) the Office of Marine Navigation Aids Regulation consents.
- (3) Where the Marine Navigation Aids Commission enters or seeks to enter into hire or service agreements—

(a) expenditure of the Commission incurred in connection with the agreements, and with the Office's consent, shall be paid out of the General Lighthouse Fund, and

- (b) sums received by the Marine Navigation Aids Commission under the agreements shall be paid into the General Lighthouse Fund.
- (4) The Office of Marine Navigation Aids Regulation may consent to expenditure in acquiring an asset for the purpose of entering into hire agreements only if the Office thinks that the expenditure is merely preparatory or subsidiary to hire agreements in respect of other assets (such as in the case of acquiring one asset to be used with another or to be used in fitting, maintaining or converting another).

- (5) The Marine Navigation Aids Commission shall send a copy of any hire or service agreement to the Office of Marine Navigation Aids Regulation.
- (6) Consent under this section –

9 Control

For section 199 of the Merchant Shipping Act 1995 (c. 21) substitute –

"199 Control of local lighthouses

- (1) The Marine Navigation Aids Commission may give directions to local lighthouse authorities about lighthouses, buoys and beacons.
- (2) A direction may in particular relate to
 - (a) the erection or placing of lighthouses, buoys or beacons;
 - (b) their removal or discontinuance;
 - (c) their repair, maintenance or improvement;
 - (d) the manner in which they are operated.
- (3) A direction may be given only with the consent (whether general or specific) of the Office of Marine Navigation Aids Regulation.
- (4) A local lighthouse authority must comply with directions under this section.
- (5) Failure to comply with a direction without reasonable excuse is an 15 offence.
- (6) A local lighthouse authority may not without the consent of the Marine Navigation Aids Commission
 - (a) erect or place any lighthouse, buoy or beacon,
 - (b) remove or discontinue any lighthouse, buoy or beacon, or
 - (c) vary the character of any lighthouse, buoy or beacon or the mode of exhibiting lights in any lighthouse, buoy or beacon.
- (7) Nothing in this section applies to local buoys or beacons placed or erected for temporary purposes.

199A Section 199 directions: supplementary

- (1) A direction under section 199 must be in writing.
- (2) Before giving a direction the Marine Navigation Aids Commission must
 - (a) notify the relevant local lighthouse authority, and
 - (b) allow them a reasonable opportunity to make representations.
- (3) The Office of Marine Navigation Aids Regulation may withdraw consent under section 199(3).
- (4) If consent is withdrawn any direction made in reliance on it lapses (without prejudice to its validity until then).
- (5) Local lighthouse authorities guilty of the offence under section 199(5) are liable on summary conviction to a fine not exceeding level 5 on the standard scale."

10 General light dues to be paid by ships belonging to Her Majesty
